

Box 3 - Total Other Receipts for 2015/16, has been over stated by £30,000. The correct figure should be £30,589. The Authority should ensure that, in future, the Annual Return is reviewed for accuracy before approval and submission to the external auditor.

Financial Commitments

A review of the Authorities accounts has highlighted that the rent from the Crown Inn was not enough to cover the Public Works Loan for 2016/17. Consequently, the Council is subsidising the operation of the Crown Inn from other funds, including local taxation.

It is also noted that part of a £25,000 bond set aside for refurbishment of the Crown Inn has not been used for the purposes intended.

Other matters not affecting our opinion which we wish to draw to the attention of the authority

Internal Audit Report

The Internal Auditor has answered 'Yes' to Objective F in relation to petty cash. This should state 'Not Covered' as the Authority does not operate a petty cash system.

The Authority should ensure that the Internal Auditor's Report is reviewed before sending the Annual Return to the external auditors. The Authority should minute this process. If there are any errors in the Internal Auditor's Report it should either be amended by the Internal Auditor, or the Authority should provide an explanation for the error.

Box 5 interest Payment on PWLB

It has come to our attention that due to a banking error the amount paid to the Public Works Loan Board for the year 2016/17 was £10,999 this should have been £18,663. The omitted payment of £7,663.47 will be reflected in the 2017/18 accounts.



Matters reported

Publishing of Notices

The Authority must provide for the exercise of public rights as set out in the Local Audit and Accountability Act 2014 (Sections 26 and 27) and the Accounts and Audit Regulations 2015. The Regulations require the Authority to approve and publish the Annual Governance Statement and the Accounting Statement alongside a Notice of commencement and a Declaration of status of accounts.

It has come to our attention that Council documents and minutes have been posted to a Facebook Account where access is only possible via a Facebook account. The Authority did not publish the Annual Governance Statement, the Accounting Statement, and the Notice of commencement and Declaration of status of accounts on a freely available website. The Authority is therefore unable to demonstrate that it made proper provision for the exercise of public rights or publish applicable documentation as set out in the Local Audit and Accountability Act 2014 and the Accounts and Audit Regulations 2015. This represents a significant governance weakness. In our opinion the response to Assertion 3 should be "No".

Publication of minutes from meetings

We would like to draw to the attention of the Authority that all minutes of Council business should be publicly available and only those elements of business that are confidential (following the appropriate exclusion of press and public) should be excluded from the published minutes. The fact that an item or items on the agenda of particular meeting does not mean that the whole meeting is confidential. Where there are confidential items, then the meeting should move to a confidential (Part 2) meeting with the press and public excluded, although confidential minutes should still be maintained. The use of confidential items should be minimal.

All previous minutes of Council meetings should be published on a freely accessible website, or other appropriate arrangements made, with only relevant confidential items redacted.

Trading Activities

The Authority should ensure that a separate trading account for the Crown Inn is maintained and reported so that there is transparency between the Authorities main activities and the operations of the Crown Inn.

Guidance notes on completing the 2016/17 annual return

- 1. You must apply proper practices for preparing this annual return.
